The fee for 2010 participation is \$170, payable with your application (or submit \$75 deposit with application before Nov 5, 2009 and make final payment of \$95 no later than Feb 28, 2010). Fee covers one studio location per application fee. Only artist(s) permanently residing at a home studio or renting an outside studio are permitted to participate at that location. Any exceptions must be approved by application process.

Participating artists agree to be open during the following hours: Friday and Saturday, September 24<sup>th</sup> and 25<sup>th</sup> from 10:00 am to 6:00 p.m. and Sunday, September 26<sup>th</sup> from 10:00 am to 4:00 pm. Participants must provide access to a bathroom and, at least, water to tour guests. Tour guests must be able to enter the working studio. Artists must provide periodic demonstrations of their media each day of the tour. Display of finished works may be displayed as the media dictates; however, no artwork of artists not a part of the working studio may be displayed. All proceeds of sales belong to the artist. Artists will be responsible for collection of taxes as applicable by State, County, and City law. Eureka Springs Artists Studio Tour will not be responsible for collection of taxes and assumes no responsibility for same. Participants will be provided with some signage (a deposit will be required). However, artists may make additional direction signs as needed.

Photos or slides of your work are not needed at the time of application. Upon approval, digital images will be requested and should be submitted promptly to be used for immediate advertising purposes (website, postcards, tour booklet and press releases).

Artists will be required to pickup marketing materials for distribution (postcards, posters, map brochures) no later than 45 days prior to tour. Additional materials (signage, sign-up sheets and evaluation forms) will be made available at the final meeting the week of the tour.

Artists will be required to obtain a minimum of 1(one) supporting sponsorship (\$50-\$250) to be submitted no later than Feb 28, 2010.

Applications with a deposit of \$75 must be postmarked no later than Nov 5, 2009. Applications with full payment must be postmarked no later than Feb 29th, 2010. Please make a copy of your application for your records. **Send application to Craig Hirsch, Treasurer, 872 Mill Hollow Road, Eureka Springs, AR 72632. Make checks payable to 'Studio Tour'.**
